President Meeting Minutes from April 16, 2014:

- **Vice President's Report**
 - New Clubs are joining SECJSA. They are Como (Stonington) and Norwich United. Clubs aren't insured until Fall of 2014. Until then those players can't register so they are not insured. Do not play these teams until August 1, 2014
 - Recreational Soccer – Tournament last fall was a great success. Some towns participated, but not all. Need to try to have all towns involved.
- **Registrar's Report**
 - Background checks – All volunteers must have background checks performed. No Exceptions as it opens all clubs to liability that insurance won't cover
 - Player Passes – new ones are coming for the Fall. Please use what you have left and let Joe know if you need more, but they will only be used for this season. Fall 2013 passes are still valid for Spring 2013.
- **DRA Report**
 - Currently we have around 85 – 90 refs at the district level. Only 15 – 20 reliable for any given weekend. Need to get towns to bring a few individuals each to official training at district
 - Needs list of all Officials in District from individual assigners with recommendations. Can take those for sidelines at premier games with existing officials to get experience. Send to TomScagliarini@gmail.com
 - Will try to have clinic prior to Labor Day Tournament. Looking for a lot of up and coming refs to bring to things like ODP clinic at URI for a week
 - Assigners need to go to CTRef.net for Assigner course
- **New Business**
 - U18 division in Spring 2015. HS Players playing in district handled just like other divisions. All Presidents should see if there is interest in their town.
 - Coaches Clinics
 - May 17th is the Coaches Clinic at Spera. Still pending some details.
 - ECert planning at Summit Fitness. Currently working with owner on details and cost.
 - Developmental Camp
 - ages 7 – 11
 - started the Spring session last week with 30 kids.
 - Just straight training for players. Some scrimmages but mostly skill training.
 - Players separate based on ability to learn different aspects of the games.
 - \$85 per player for 15 hours of training.
