o November minutes were approved.


District Report

 - A significant portion of the meeting was spent discussing the ongoing challenges of proper team placement by Club Presidents and Coaches, particularly in the Fall. While no new

solution was discovered, there was agreement that an approved approach centered on honesty, communication among clubs ahead of final decisions, acknowledgement of and pushback against habitual offenders, and oversite by SECJSA leadership (Registrar) based on prior season performances would help to improve fair and balanced play in the future.

- There was strong agreement that no Premier/Club players are to be rostered or participate in any Broze games/team (and most often should be prevented from the Silver division, too)
- Discussion was had about the 6-goal differential rule and while many seemed in favor of eliminating this, further discussion and a formal vote will take place at the next SECJSA meeting

Referee Report

- o **Referee recertification / new referees:** Currently registered referees around 1,900. Down about 500-600 from where we ended last year. Lot of late recertifications in March expected, but anticipation is that we will be under last years numbers by several hundred when all is said and done. We are chasing assignors that have not re-certified, and clubs that are using people that are un-registered.
- o New email addresses for referee program: ct-syra@ctreferee.net. Please always use this email address when communicating with the referee program.
- o Referee Assignor requirements changes. It is now required for all "NEW" assignors too also become certified as a referee. Existing assignors are grand-fathered.
 - 15 of our 19 clubs need to have their assignors recertified.
- Referee field course: Colchester and Waterford are interested in offering the referee field course certification in their respective towns
