- **District Report**

- The Southeast District will provide a full refund for any Southeast coach that takes the US Soccer Grassroots Coaching Certificate. Coaches may be reimbursed directly by SECJSA, or via their Club who will be reimbursed by SECJSA. A completed course certificate must be shared in order to be reimbursed. SECJSA may consider partial reimbursement for the D license.
- SafeSport: SafeSport must be completed by all coaches, club administrators, Boards members, or any volunteer who interacts with players. Clubs must reinforce this and ensure that everyone completes SafeSport prior to the start of the season (SafeSport must be completed annually). You may view in Stack who has and has not completed SafeSport for the 2024-2025 season.
- Hartford Athletic game Oct. 12: SECJSA may attend the Hartford Athletic final home game on Oct. 12, but Joe realizes that this may pose a conflict due to Columbus Day Weekend and various soccer tournaments.
Joe will reach out to Clubs to help assess interest. If we move ahead, players, Coaches, and Club Admins. may attend the game for free and parents of player will be offered discounted tickets.
